## **Attachment 2: LBCCG Coordinator Report**

### **Current Projects**

#### **Cork Dairies Laneway Rehabilitation (Cork)**

- Ongoing monitoring of the Project is continuing with Seqwater scientists re-calibrating the Control 'Sonde' and taking 'grab' samples from the property.
- Laneway rehabilitation is continuing although we have gone from being too dry to too wet to too dry again.
- Unfortunately, an application to BMRG for riparian fencing and off stream watering was rejected. There may be another avenue for funding these components however.

#### **Upper Obi Obi Creek Rehabilitation (Farmhouse Macadamias)**

- Revegetation by the National Green Jobs Corps has commenced.
- I attended the program launch in late August in Mudjimba.
- A Progress Report was submitted to the Commonwealth Government

#### **Bridge Creek Rehabilitation (McLauchlan)**

- Final Report to Commonwealth Government submitted (Community Action Grant component)
- Further revegetation completed linking previous years sites.
- A Progress Report was submitted to the Commonwealth Government

### **Project Development**

#### **Whardjin Creek landslip**

- Assisting the landholder to apply for a Sunshine Coast Council Landholder Grant and providing advice where required on the management of the slip.

#### **Maleny Community Precinct Water Quality Monitoring Project**

- Andrew Watkinson from Seqwater visited the MCP to further investigate the possibility of Seqwater including the site in their program. From this visit, Andrew Smolders is meeting with Unitywater to discuss their monitoring of the Northern Wetland and if they will/are amenable to expanding their monitoring to include further areas.

### **Other**

- 2011-12 Priority Strategy for Funding Provided by Seqwater completed. This document reviews last year's projects and outcomes and provides a detailed project budget for the coming year. This is presented to Seqwater with our request for funding and associated invoices.
- LBCCG have 1 ticket for 1 day at the upcoming Rivers Symposium in Brisbane in September. Mark cannot attend so Gillian will utilise the ticket.
- Met with BMRG General Manager Danny Green
- Conducted a tour of LBCCG projects with the Burnett Mary Region Landcare Facilitator
- Hosted a meeting with Council Waterways Managers to discuss potential partnerships
- Submitted an article for the BMRG Newsletter on the Cork Dairies project highlighting the unique and comprehensive monitoring program being implemented.
- LBCCG has purchased a new Ford Ranger twin cab 4WD. Through an excellent deal with Q-Ford at Springwood we basically purchased a new vehicle for second hand price.
