## **Attachment 2: LBCCG Coordinator Report**

### **Current Projects**

#### **Cork Dairies Laneway Rehabilitation (Cork)**

- Monitoring of the Project is continuing with Seqwater scientists re-calibrating the Control 'Sonde' and taking 'grab' samples from the property. The usual water quality parameters are being tested – including Cryptosporidea and Giardia (pathogens) that are very expensive to analyse.
- Laneway rehabilitation has commenced however the dry conditions are hampering efforts at getting sufficient compaction.

#### **Upper Obi Obi Creek Rehabilitation (Farmhouse Macadamias)**

- Project area has been marked out and approved by the NSW based owner of Farmhouse Macadamias.
- Corflute tree guards and weed mats have been purchased in readiness for the commencement of planting in September.
- Site preparation expected to commence in early August.

### **Project Development**

#### **Upper Lawley Creek**

- Discussions are continuing about a collaborative project on the site between LBCCG and Sunshine Coast Council.
- A Caring For Country Community Action Grant was submitted to fence and revegetate a section of Lawley Creek

#### **Maleny Community Precinct Water Quality Monitoring Project**

- Precinct was visited by Seqwater Water Quality Scientists and myself to investigate the possibility of Seqwater including the site in their routine catchment-sampling program. Further site visits will be required.

### **Publicity**

- Mark Amos has won the Burnett Mary Regional Group 2011 Coordinator Award.

### **Other**

- 2010-11 Project Summary document has been completed. This Summary lists all the projects commenced in the 2010-11 year, listing the LBCCG works and outcomes.
- Assisted Green Hills application under the Community Action Grants funding program
- Met with Seqwater consultants providing information to produce a Catchment Investment Efficiency Model – placing a \$ figure on sediment accumulating in Baroon pocket Dam (including treatment costs)
- Organised a meeting with BMRG General Manager Danny Green
- Organised a visit by Burnett Mary Region Landcare Facilitator – looking at LBCCG projects
- Organised a meeting with Council Waterways Managers to discuss potential partnerships
